The Difference between In-Text Citations and Reference Lists

In-Text Citations

Your report or essay should have in-text citations that back up the points you are making. This is an example of a paragraph that has in-text citations:

Social science is a very broad field. To many, it means the study of virtually all the academic disciplines one might name for the purpose of preparing active, thoughtful citizens (Caron, 2008). Such study creates good democratic citizens who engage and participate in the affairs of their communities and pursue social justice agendas (Drew & Bingham, 2010). According to Sandahl (2019), studying the social sciences helps students to explore issues in society that can encourage them to participate in the political process. In addition, studying social science can instil a wish to take part in effecting social change (Costelloe et al., 2018).

Quotes

If you are using a quote, you have to add additional information.

-page number (Wepa, 2018, p. 23)

-paragraph number (Wepa, 2018, para. 23)

-section heading (if unpaged) (Wepa, 2018, Cultural safety section)

Example where the citation is part of the narrative:

Caron (2008) states that a study in 2008 found that "55% of CEOs prefer to hire staff who have studied the social sciences" (p.34).

Example where the citation comes at the end of the sentence:

"55% of CEOs prefer to hire staff who have studied the social sciences" (Caron, 2008, p. 34).

Notice the full stop comes after the citation.

- Put the full details of the sources used
- Indent second and subsequent lines
- Put in alphabetical order
